

SINGAPORE AIRLINES & CHILDREN'S UNIVERSITY ADELAIDE

Two (2) return Economy Class tickets to Singapore flying Singapore Airlines (via Singapore).

Terms and Conditions

The following conditions apply to this prize:

1. Travel is to be on Singapore Airlines services to/from Adelaide only (SQ278/SQ277/SQ276 and SQ279).
2. The tickets are for return travel in Economy Class. No upgrades are permitted, paid or unpaid.
3. The recipient is responsible for all applicable government and security taxes and levies, insurance surcharges and airport charges. These taxes must be paid at least five working days prior to travel.
4. Travel must be between 01 December 2016 and 31 March 2018. Travel must be fully completed by 31 March 2018.
5. No travel permitted between the following dates: 19 December – 31 December 2016, 01 January – 06 January 2017, 21 January – 05 February 2017, 15 September – 19 September 2017 and 19 December – 31 December 2017, 01 January – 06 January 2018, 21 January – 05 February 2018
6. Maximum stay is up to 3 months abroad.
7. Travel is subject to availability at the time of booking.
8. Prize-winner must book the flights within 2 (two) months of notification of winning the prize
9. Changes including, but not limited to date changes, rerouting and name changes are not permitted after ticketing.
10. Prize consists of one ticket registered in the name of the prize-winner and a traveller of their choice.
11. Tickets cannot be sold in any way.
12. If prize-winner cannot travel for any reason, one ticket (the prize-winner's) is forfeited.
13. The prize-winner must use the two (2) tickets within the same booking, and the passengers must travel with each other at all times including the same flights, itineraries and dates.

23. All special meals including dietary requirements must be advised at least 3 working days prior to departure.
24. Children under the age of 18 are not eligible to enter.
